- **Rebate of \$800 for qualifying Air to Air or Geothermal Heat Pump. Equipment must meet the DOE manufacturing standard for HSPF efficiency. DOE standard is currently 8.2. Limit 1 rebate per customer account.**
- **The appliance must be installed within RSCPA's service territory.**
- **Fill out this form completely. Incomplete forms will not be processed.**
- **Include a copy of the original, dated sales receipt.**
- **Include your account number and sign the form.**
